- 11. Ensure that incubated startups get graduated with financial sustainability by providing necessary handholding and support.
- 13. Drive the planning and execution of startup related events each year and other initiatives, to attract and ontarget startups.
- 14. Ensure availability of suitable mentors, partner institutions and corporates.
- 15. Ensure financial sustainability of the incubator as per the budget committed to, and approved by Board of Directors.
