ORDER

WHEREAS, Periyar Maniammal University, Department of Education School of Humanities Universities, Science & Management, Periyar Nagar, Vallam, Thanjavur-613403, Tamilnadu had submitted an application for B.Ed Course on 17.06.2008. The institution was granted recognition on 25.09.2009 with an annual intake of 100 students, with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution vide its letter dated 20.12.2011 submitted its proposal for change of premises for the programme within the University campus. Accordingly, a letter was sent to the institution seeking for Rs. 40,000/- towards change of premises along with documents on 04.01.2012.

AND WHEREAS, the institution vide its letter dtd. 08.02.2012 has submitted the required documents and DD bearing no. 644257 dtd. 25.01.2012 for Rs. 40,000/- towards change of premises fee.

AND WHEREAS, the NCTE, Hqrs vide letter dtd. 27.02.2012 had forwarded a complaint dtd. 16.01.2012 which was received against the institution from Dr. B. Ramaswamy, Mayur Vihar, Delhi-110091. NCTE, Hqrs has stated that "some allegations have been made by complainant against the aforesaid institution. You are, therefore, requested to examine the matter and to take necessary action against the institution as per the NCTE Act, 1993, by placing the complaint before the Regional Committee and to furnish action taken to NCTE, Hqrs., New Delhi within a month".

AND WHEREAS, the SRC in its 219th meeting held on 15th-16th March, 2012 considered the matter and decided to call for Affidavit from the complainant. Also the committee decided to call for comments from the institution after receiving the affidavit from the complainant.

AND WHEREAS, a letter was sent to the complainant on 13.04.2012. The complainant has not submitted any written representation/affidavit till date.

AND WHEREAS, the institution has submitted shifting inspection fee of Rs. 40,000/- on 08.02.2012. Further, as per NCTE notification dated 13.09.2011, the institution is required to submit another Rs. 10,000/- (ten thousand) as shifting fee as per norms.

AND WHEREAS, further, the NCTE Hqrs has forwarded a complaint against the institution on 06.12.2012 from Dr. B.Ramaswamy, Mayur Vihar, Delhi-110091 and has requested to take necessary action against the institution as per the NCTE Act, 1993, by placing the complaint before the Regional Committee.

AND WHEREAS, the SRC in its 236th meeting held on 16th -17th December, 2012 has considered the complaint matter and reply of the institution dt. 08-02/2012 and all other relevant documents and decided to cause inspection under section 14 (1) of NCTE Act, to examine whether the institution fulfils all the requirements as per the norms, for the proposed programme, subject to the condition that the deficiencies, if any, were duly rectified by the

institution, as per the norms, after collecting balance of inspection fee of Rs. 10000/- and instruct VT members to look into the specific allegations in the complaint.

AND WHEREAS, the inspection of the institution was fixed between 15th-19th January 2013. The same was intimated to the institution on 08.01.2013. The inspection was conducted on 19.01.2013 and the institution has submitted balance of inspection fee of Rs. 10000/- by DD bearing No.543665 dt.17.01.2013.

AND WHEREAS, the SRC in its 241st meeting held on 29th & 31st March & 01st April 2013 has considered the VT report, VCD of the institution and advised Southern Regional Office to put up the details in the standard format.

AND WHEREAS, the SRC in its 242nd Meeting held on 14th -16th April, 2013 has considered the VT report, VCD and also the relevant documents of the institution and decided to withdraw recognition for the following reasons:-

1. Certified copy of land documents issued by the Sub-Registrar is not submitted. If the documents are in Tamil, Notarised English version of the same is required.
2. Non-Encumbrance Certificate is not submitted in original and the University has submitted Non-Encumbrance Certificate in the name of Periyar Maniammal Institute of Science and Technology and not in the name of Periyar Maniammai College of Technology for Women. This needs clarification. Notarised English version of Encumbrance Certificate is required.
3. The University has submitted the Deed of Declaration in the name of Periyar Maniammai College of Technology for Women. Whereas, the Non-Encumbrance Certificate is in favour of Periyar Maniammal Institute of Science and Technology. This needs clarification.
4. The University has submitted photocopy of the affidavit. In the affidavit built-up area is not mentioned. Hence, fresh original affidavit showing built-up area is required.
5. Blue Print of the Building Plan required, if the approving authority is in Regional Language, Notarised English version of the same required.
6. Original FDRs of Rs. 5 lacs and Rs. 3 lacs from Nationalised Bank for a duration of 5 years required.
7. Principal/Head is having only 4 years of Teaching experience in college of Education. As per NCTE norms Ten years teaching experience is required out of which at least 5 years teaching experience in a Secondary Teacher Education institution.
8. Lecturer in Foundation course and Methodology course are not identified. Lecturer in Art Education is not having Master Degree in Fine Arts/Music with 55% marks. Hence, Lecturer in Art Education with required qualification required to be appointed as per NCTE norms.
9. As per NCTE norms at least one lecturer should have specialization in ICT and another in the special education.

AND WHEREAS, the institution has failed to follow the rigid application of NCTE norms and standards. It is a case of strict application of norms and standards as directed by S,C, in their order dt. 31-01-2011 in case Civil Appeal No.1125-1128/2011 in SLP, SLP No. 17165-68/2009 filed by NCTE Vs ors, which reads as under:

"An institution is not entitled to recognition unless it fulfills the conditions specified in various clauses of the Regulations. The Council is directed to ensure that in future no institution is granted recognition unless it fulfils the conditions laid down in the Act and the Regulations.

AND WHEREAS, based on the above points the committee decides to withdraw the recognition of the B.Ed course run by the Periyar Maniammal University, Department of Education School of Humanities Universities, Science & Management, Periyar Nagar,

Vallam, Thanjavur-613403, Tamilnadu, from the academic year 2013-14, in order to enable the ongoing batch of students in B.Ed, course, if any, to complete their course.

AND WHEREAS, withdrawal order was issued to the institution on 24.05.2013.

AND WHEREAS, the institution vide its letter dtd. 30.08.2013 has stated that

" our application on 29.10.2009 to SRC, NCTE, Bangalore for recognition of B.Sc.Ed., (4 year integrated programme), we were advised to present our proposal of B.Sc.Ed., programme before the Standing Committee, New Delhi (letter dated July 19, 2013) (Ref.4) and has requested the SRC, NCTE, Bangalore to process our application further.

The norms for B.Sc.Ed. Programme has been released in the website (minutes of 236th meeting of SRC, NCTE, Bangalore) and our application has not been further process so far.

In this connection, we would like to submit that we have provided all infrastructures for starting this programme and we are in full preparedness to provide this programme to the students of this region who hails from rural areas. We therefore, request you to kindly process our application to accord final recognition to the B.Sc.Ed. (four year integrated) programme at the earliest and oblige".

AND WHEREAS, the institution preferred an appeal to NCTE, Hqrs and the Appellate Authority vide order no. F.No.89-390/2013 Appeal/14th Meeting-2013 dtd. 07.11.2013 has stated as follows:-

" after perusal of the documents, memorandum of appeal, affidavit and considering the oral arguments advance during the hearing, the Council concluded that the appeal deserved to be remanded to SRC with a direction to issue a show cause notice to the appellent institution within 15 days from the date of issue of the order in the appeal and thereafter complete further processing as per the Regulations within 45 days. In the meantime the order of withdrawal should be kept in abeyance.

NOWTHEREFORE, the Council hereby remands back the case of Periyar Maniammal University, Thanjavur, Tamilnadu to the SRC, NCTE, for necessary action as indicated above".

AND WHEREAS, the SRC in its 256th meeting held on 04th -06th December, 2013 has considered the appellate authority order dated 07/11/2013 directing to take necessary action and advised Southern Regional Office to process the case and put up.

AND WHEREAS, the application was processed and placed before SRC in its 259th meeting held on 17th -19th January, 2014 and the committee considered the matter, Appellate Authority order dated 07/11/2013 and decided that the University to be asked to file staff list, in accordance with NCTE norms, as approved by the University and signed by the Registrar.

AND WHEREAS, by seeing the website, the University has submitted written representation on 24.01.2014 along with staff profile list approved by the Registrar, Periyar Maniammal University.

AND WHEREAS, the SRC in its 262nd meeting held don 17th -19th February, 2014 has considered the Appellate authority order dated 7/11/2013, also reply of the institution vide letter dated 24/01/2014 all other relevant documentary evidences and decided to allow for shifting of the institution to the new premises.

Note: The University to be asked to submit the approved staff list in the format prescribed by NCTE.

NOW THEREFORE, permission is hereby accorded by SRC to Periyar Maniammal University, Department of Education School of Humanities Universities, Science & Management, Periyar Nagar, Vallam, Thanjavur-613403, Tamilnadu to shift its premises to the new location / building at Periyar Maniammal University, Department of Education, Vallam – 613403, Thanjavur for B.Ed Course.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
