In order to avoid rush and overcrowding at the Institute main entrance, during the working hours, the vehicle parking place for the students has been regulated from 06.07.2022 onwards.

Hence, all the Boys students are directed to park their vehicles at the new vehicle shed behind the **Periyar TBI Building**. They enter and leave the campus through the passage existing beside the Indian Overseas Bank. After parking the vehicle, they are allowed to go to the Main Building by using the Periyar Maniammai Hospital route.

The Girl Students are informed to enter and leave the campus through Main Gate and park their Two Wheelers in the vehicle shed adjacent to the Security Office.

Other pedestrians are informed to enter/leave the campus through the Main Gate.
